## **2019 Vendor Rules and Regulations** *Applicable to ALL vendors.*

### **Hours of Setup & Operation:**

Thursday, September 5<sup>th</sup>

- Setup, 12:00 PM- 7:00 PM

Friday, September 6<sup>th</sup>

- Setup, 7:00 AM – 9:00 AM
- Operation, 10:00 AM – 9:30 PM

Saturday, September 7<sup>th</sup>

- Operation, 9:00 AM – 9:00 PM

All Vendors must be open for business on Friday, September 6<sup>th</sup> at 10:00 AM and shall remain open and operational during the hours identified above, until the conclusion of the MSRR Finals on Saturday, September 7<sup>th</sup>.

Vendors may begin setting up at 12:00 PM on Thursday, September 5, 2019. Please call 970-640-0049 when you arrive for check-in. Contact the office **in advance** if you need directions or have unique set-up requirements.

### **Tear Down:**

All vendor booth spaces must remain intact and operational until the conclusion of the MSRR Finals Rodeo on September 7<sup>th</sup>. All exhibitor materials must be removed by no later than 10:00 AM on Sunday, September 8<sup>th</sup>.

### **Approval, Selection, and Location:**

Spaces are assigned based upon electrical needs, historical participation and early registration. MSRR, LLC will attempt to honor any requested booth location, although the final location of any vendor remains the decision of the MSRR, LLC. All assigned vendor spaces are final and will not be changed.

### **Compliance with State and Local Regulations:**

All vendors are solely liable for compliance with all State and Local regulations related to the sale of products at MSRR, LLC events. Vendors must have required permits and licenses.

### **Assignability or Subcontracting:**

Any assignment, transfer or subcontracting of this MSRR' LLC Vendor Application or Approval is prohibited, unless written consent is obtained from MSRR, LLC.

### **Cancellations:**

Cancellations are without penalty until July 31, 2019. Cancellations received after this date will be charged in full without refund. Request for cancellation must be received in writing to MSRR, LLC 22114 Government Springs Road Montrose, CO 81403

**Approvals/Payments:**

Approved vendors will receive a notice from MSRR by July 25, 2019. If you have not received your notice by August 1, 2018, please contact MSRR, LLC at 970-640-0049. If your application is not approved, your fees will be returned in full.

**Deadlines:**

Vendor applications are due at MSRR, LLC no later than **July 25th, 2019**. Incomplete applications will not be accepted.
